

## SHIPPING YOUR FREIGHT TO AAPEX (VENETIAN EXPO)

There are a number of ways to ship your materials to AAPEX:

### FREEMAN ADVANCED WAREHOUSE:

*(via common carrier, van lines or company truck)*

This option is best if you want to begin setup at your assigned target time.

Freeman will begin accepting advance warehouse shipments on **September 24, 2024**.

The deadline date for shipment to the Freeman Advanced Warehouse is **October 17, 2024**. Additional fees will apply after the deadline date.

### DIRECT TO THE VENETIAN EXPO VIA MARSHALLING YARD:

- If you are using a common carrier, van line or company truck, they must use the Freeman Marshalling Yard and arrive at your assigned target time.
- Please refer to the Target Move-In Schedule for your assigned target date.

### DIRECT TO VENETIAN EXPO VIA PRIVATELY OWNED VEHICLE (POV)/FREEMAN ASSISTED:

If you are driving a privately-owned vehicle (POV), which is an employee-driven car, truck, or passenger van, you can proceed directly to the Venetian Expo.

- Freeman will receive shipments at the exhibit facility beginning October 31, 2024.
- Shipments arriving before this date may be refused by the facility.
- Any charges incurred for early freight accepted by the facility will be the responsibility of the exhibitor.
- Certified weight tickets must accompany all shipments.
- Ensure your driver has the following information to expedite unloading and delivery to your booth: Show Name, Exhibitor Name, Booth #.
- If required, provide your carrier with this phone number: (888) 508-5054.

## **DIRECT TO VENETIAN EXPO VIA HAND CARRY/SELF-UNLOAD:**

- Only company employees can hand-carry freight.
- Booth materials and product can only be carried by one person at a time. Any materials/product that require more than one person to carry will NOT qualify.
- You must have an additional person to stay with the vehicle while loading and unloading. Any vehicle left unattended will be subject to towing.
- Unloading must be done within 30 minutes.
- Use of a small, non-industrial, two-wheel dolly is permitted.
- Other wheeled devices are prohibited.

## **PRIORITY CARRIERS (DHL, FEDEX OR UPS):**

Shipping materials overnight or ground directly to the Venetian Expo should be sent to:
